- (4) what are the details of all SRI projects (a) currently on hold and (b) not yet completed;
- (5) what are the details of all SRI projects planned for the 2015-16 financial year?

- (1) The following facts and findings are consistent in all the reports:
 - (a) Non-compliance with the conditions of the Memorandum of Agreement, and
 - (b) inaccurate reporting on the status of projects

- Limpopo Province Tshakuma Heritage and Conference Centre the case is in court for prosecution;
- Easter Cape Province Wild Coast Tourism Development the case is with the SAPS for further investigation;

- KwaZulu-Natal Province King Matiwane Village the case is with the SAPS for further investigation;
- Free State and Northern Cape Province training projects the case is with the SAPS for further investigation;
