1. INHLOSO YALEMANUWALI

Sigaba 32 (1) seMtsetfosisekelo weRiphabhulikhi yaseNingizimu Afrika, wanga 1996 simise kutsi wonkhe umuntfu unelilungelo lekufinyelela kunome wuphi uMniningwane lobanjwe nguMbuso kanye nalomunye nje umniningwane longabanja nanobe ngubani, longadzingeka ekusetjentisweni nobe ekuvikeleni nanobe nguliphi lilungelo. *I-Prmototion of Access to Information Act, 2000 (Umtsetfo Nom. 2 wanga 2000)* (lana yatiwa nge- “PAIA”) i – PAIA iyanaka kwekutsi lilungelo lekufinyelela kumniningwane lihambisana nemikhawulo letsite lenebulungiswa.

Imininingwane yemarikhodi legcinwe ngumtimba wemphakatsi acuketfwe ebhukwini lelatiwa ngemanuwali. Lemanuwali ihlobene nemarikhodi lagcinwe ngumtimba wemphakatsi. - (b) Lofaka sicelo kufaneke asho kutsi angatsanza kutfola ikhophi yelirikhodi nobe angatsanza kucwaningela lirikhodi kuwo emahhovisi emtimba wemphakatsi. Lenye indlela, uma ngabe lirikhodi lingasiwo umculu loliphepha, lingavulwa ngelifomu leliceliwe nakukhonakala.
- (c) Uma ngabe lofaka sicelo acela kufinyelela ngelifomu lelitsite, utawutfola kufinyelela ngendlela layicelile. Lomtsetfo uyasebenta, ngaphandle uma ngabe kwenta njalo kutawutsikabeta kusebenta kweMnyango, nobe kulimate lirikhodi, nobe kweca imitsetfo lengasiyo yembuso, uma ngabe kufinyelela kungeke kwanikwa ngendlela lefanele, kodvwa ngendlela lenye, imali lebhadalwako iyawubalwa ngendlela lofake scelo bekacele ngayo ekucaleni.

9.2 Kufakela lomunye sicelo

Uma ngabe sicelo sifakelwa lomunye umuntfu, lofaka sicelo kufuneka amikise bufakazi lobukhutsata kutsi angasifaka sicelo, lapho nakwentiwa leso sicelo Sekela weNhloko yeliHhovisi leMniningwane ahambisane naso sicelo.

9.3 Sicelo lesentiwa bantfu labakhubatekile

- (b) Sekela weNhloko yeliHhovisi leMniningwane (nobe lincusa lakhe) utawuncedza lofaka sicelo kutsi alandzele konkhe lokudzingekile lokubalwe ngenhla kucela kufinyelela kumniningwane, lokufaka ekhatsi kutfumela lofakasicelo kulomunye umtimba wemphakatsi, uma ngabe sicelo semniningwane bekudzingeka kutsi siye khona.

9.4 Kutfunyelwa kweticelo

 - i. Uma ngabe lirikhodi libanjwe ngulomunye umtimba wemphakatsi;
 - ii. Lokucuketfwe kulelirikhodi kuhlobene kakhulu nemisebenti yalomunye umtimba wemphakatsi;
 - iii. Lirikhodi belakhelwe lomunye umtimba wemphakatsi, nobe lamukelwa kucala ngulomunye umtimba; nobe
 - iv. Lirikhodi licuketse umniningwane ngetekuhweba lotsintsana netidzingo tetemnotfo kanye nenhhalakahle yetetimali yeRiphabhulikhi kanye nekusebenta kwetetimali kumtimba wemphakatsi.
- (b) Itimeni letifana naleti, Sekela weNhloko yeliHhovisi leMniningwane (nobe lincusa lakhe) kuyawudzingeka atfumele ticelo kulolomunye umtimba wemphakatsi ngekushesha, kepha kungakedluli emalanga langu 14 kwemukelwe sicelo. 11.1 Sikhalo sangeKhatsi

11.2 Lifomu

- (a) Lofaka sicelo angadlulisa sikhalo sangekhatsi ngesincumo saSekela weNhloko yeliHhovisi leMniningwane sekwalela sicelo, nobe sesicelo nemali yekufinyelela, nobe kukhulisa kwesikhatsi sekusetjwentwa kwesicelo, efomini lelifanele lelikhoshwe ekuMisweni kweMtsetfo ngekwe PAIA, nobe lifomu lelihambisanako. Ikhophi yalelifomu ihlanganiswa nalemanuwali njenge *Annexure B*. Emakhophi alelifomu ayatfolakala futsi emaHhovisi eMnyango nobe kuSekela weNhloko yeliHhovisi leMniningwane lekukhulunywa ngaye kulemanuwali. Lelifomu liyatfolakala futsi kuwebhusayithi yeMnyango.
- (b) Lokhalako kufuna anikete tizatfu tekubuyeketwa kwesikhalo sangekhatsi, uyawufuna kwatiswa njani ngesincumo mayelana nesikhalo aphindze abhadale nemali lencunyiwe yekukhala (nayikhona)
- (c) Ngemuva kwekutfola sikhalo, iNhloko yeHhovisi leMniningwane kufuneka imikise kuNgcongcoshe sikhalo sangekhatsi, tizatfu tesincumo, kanye naleminye imininingwane nobe sandla sesitsatfu lesingaba khona, kungakedluli emalanga lalishumi (10) ekusebenta.
- (d) Sikhalo kufanele sibekwe ekhatsi kwemalanga langemashumi lasitfupha (60) nobe nakudzingeke kutsi kwatiswe lowesitsatfu ngekwasigaba 49(1)(b) we-PAIA, kungakedluli emalanga langemashumi lamatsatfu (30) ngemuva kwekuba satiso sineketwe lokhalako ngekungahambisani nesincumo ngesikhalo sakhe, nobe uma satiso kulokhalako uma singadzingakali, ngemuva kwekutsi kutsatfwe sincumo, sikhalo kufanele sicondziswe ekhelini, kunombolo yefekisi nobe kumeyila ya-Sekela weNhloko yeliHhovisi leMniningwane.
- (e) Ngcongcoshe utawuvumela kuhlehlisa kwekubekwa kwesikhalo kuphela uma ngabe lokhalako sivakala sizatfu sakhe. Etimeni lapho lokhalako afake sikhalo sekudlule sikhatsi lesifanele, umfaki wesikhalo utawatiswa kwekutsi sikhalo sakhe lesesidlulellwe sikhatsi sivunyelwe nobe asikavunyelwa.
