1. IHLOSO YEMANUWALI

ISigaba 32 (1) soMthethosisekelo weRiphabhliko yeSewula Afrika, we-1996 siqalela bonyana woke umuntu unelungelo lokuthola nanyana ngiliphi ilwazi eliphethwe mbuso begodu nananyana ngiliphi ilwazi eliphethwe ngomunye umuntu elidingengelwa ukusetjenziswanofana ukuvikelwa kwananyana ngiliphi ilungelo. *I-Promotion of Access to Information Act, 2000* (uMthetho weNomboro 2 wee-2000) (ukusuka la ukuyaphambili ubizwa nge-“PAIA”). Nanyana kunjalo i-PAIA itjheja bonyana ilungelo lokuthola ilwazi lilawulwa mikhawulo ethileko efanelekileko.

Imininingwa yama rekhodi agcinwe liphiko likarhulumende elilawulako amumethwe ngaphakathi kwencwadi ejayeleke ngokwaziwa njenge manuwali.  - (c) Ngaphezu kwependulo emtlolo esibaweni serekhodi, nangabe umfaki wesibawo ufunu ukwaziswa mayelana nesiqunto ngananyana ngiyiphi enye indlela, isibonelo, ngomrhala, lokhu kufanele kutjengiswe.
 - (d) Nangabe umfaki wesibawo ubawa ilwazi esikhundleni somuntu omunye, iinzathu ekufakwa ngazo isibawo kufanele zitjengiswe.

9.2 Isibawo sesikhundleni somunye umuntu

Nangabe isibawo sibawa esikhundleni somunye umuntu, umfaki wesibawo kufanele athumele ubufakazi beenzathu ezimenza afake isibaweso, ngendlela ezakwanelisa ngokufaneleko ISekela lesiPhathiswa sezeLwazi.

9.3 Isibawo sabantu abanokukhubazeka

- (a) Nangabe umfaki wesibawo akaghoni ukufunda nofana ukutlola, nofana nangabe unokukhubazeka ekumukhandela bona angaghoni ukugcwala iforomu elibekiweko, lapho-ke angenza isibawo ngomlomo. ISekela lesiPhathiswa sezeLwazi (nofana isithunywa salo) lizakugcwala iforomu esikhundleni somfaki wesibawo begodu siphe umfaki wesibawo loyo ikhophi leforomu eligcwaliweko.
- (b) ISekela lesiPhathiswa sezeLwazi (nofana isithunywa salo) sizakusiza umfaki wesibawo ukukhambiana neemfuneko ezivezwne ngehla zokufaka isibawo sokufumana ilwazi, ekufaka hlangana ukudluliselwa ephikweni elinye komfaki wesibawo, nangabe kusolelwabonyana isibawo selwazesobekufanele sithunyelwe kelinye iphiko likarhulumende elilawulako.

9.4 Ukudluliswa kweembawo

- (a) limbawo zamarekhodi zingadluliselwa kelinye iphiko likarhulumende elilawulako ngaphasi kobujamo obulandelako:
 - (i) Lokha irekhodi naliphethwa ngelinye ibandla lombuso;
 - (ii) Indabamraro yerekhodi nayihlobene khulu nemisebenzi yelinye iphiko likarhulumende elilawulako;
 - (iii) Irekhodi lenzelwa elinye iphiko likarhulumende elilawulako, nofana lamukelwa kokuthoma ngelinye iphiko likarhulumende elilawulako; nofana

- (iv) Irehodi limumethe ilwazi lezokurhweba eliphathelene neenrhuluphelo zomnotho kanye nezhelalakuhle zeemali zeRiphabhliki, begodu nemisebenzi yokurhweba kwephiko likarhulumende elilawulako.
- (b) Ebujamenobo lapho iSekela lesiPhathiswa sezeLwazi (nofana isithunywa salo) lizakufanele lidlulisele isibawo kelinye iphiko likarhulumende elilawulako msinyazana ngendlela ezwisisakalako ekungakghonakala ngayo, kodwana kungasi ngemva kwamalanga alitjhumi nane (14) ngemva kokufunyanwa kthesibawo. Nangabe iphiko likarhulumende elilawulakonofana isiPhathiswa sezeLwazi ekuthunyelwe kiso isibawo liphethe irekhodi begodu sibona kulisizo ukwenza njalo ukwenzela isiPhathiswa sezeLwazi selinye iphiko likarhulumende elilawulako ukuthi sisebenze ngesibawo, irekhodinofanaikhophilerekhodi lizakuthunyelwa kiso lesosiPhathiswa sezeLwazi.
- (c) Nangabe isibawo sokuthola irekhodi sidlulisiwe, kufanele sifakte ngaphakathi komtjhiningqondo ukusuka ngelanga lokuthoma esatholakala ngalo. Zoke iinkhathi ezifaneleko ezisebenzako esibaweni selwazi kufanele zilandelwe.

9.5 Izasizo sokudluliswa

- (a) Lokha isibawo sokuthola ilwazi sidlulisiwe, iSekela lesiPhathiswa sezeLwazi esenza umsebenzi wokudlulisokho lizakwazisa umfaki wesibawo msinyazana mayelana:
 - (i) nokudluliswa;
 - (ii) neenzathu zokudluliswa; begodu
 - (iii) nesikhathi ekufanele isibaweso kusetjenzwe ngaso.
- (b) ISekela lesiPhathiswa sezeLwazi lizakuqinisekisa ngendlela efaneleko bonyana irekhodi liyabulungwa ukufikela lapho isiqunto sithathwa khona mayelana nokutholakala kwelwazelo. Isikhathi esibekiweko sesinghonghoyililo sizakufakwa hlangana.

Imbadalo yesibawo ebhadalwako yi-R35-00 njengokubekwe miThetholawulo ku-PAIA.
