

INCENTIVE, BUSINESS TRAVEL AND MEETING EXHIBITION (IBTM): BEIJING, CHINA "INVITATION TO SUBMIT APPLICATIONS HAS BEEN EXTENDED FOR IBTM CHINA EXPO"

The National Department of Tourism (NDT) through the Tourism Incentive Programme (TIP) invites eligible tourism enterprises to apply for the IBTM China Expo that will take place from 23-24 August 2017 in Beijing, China.

IBTM China is a unique hosted buyer programme, hosting over 450 top level decision makers who place international business, and facilitating over 8 900 one to one appointments between exhibitors and buyers. IBTM China has over 4 000 attendees from around the world. Exhibitors includes international venues, hotels, destinations, technology, business travel and events services providers essential for meetings. It provides the ultimate platform for the world's leading suppliers to **MICE** industry to meet top level buyers with strong purchasing power who are responsible for organising and planning meetings, events and business travel, both in China, Asia and the rest of the world.

The National Department of Tourism under the International Market Access Support Programme (IMASP) will support a limited number of enterprises to attend the 2017 IBTM China Expo and is specifically aimed at assisting small and medium tourism enterprises that wishes to showcase packaged experiences to buyers in the China market. For the IBTM China Expo 2017, the Department will offer partial financial assistance on a reimbursement basis, to qualifying enterprises in respect of capped amounts towards the cost of airfare and accommodation, as well as participation/exhibition fees.

Reimbursement of costs incurred is subject to the following capped amounts:

- Accommodation- R2 620 per person per night, linked to the duration of the exhibition
- Flight- R 26 316, based on an economic class return flight, and
- Participation/exhibition fees R55 586.40 towards exhibition fees will be paid by the Department directly to the exhibition organiser.
