## CALL FOR APPLICATIONS INTERNATIONAL TRAVEL WEEK ABU DHABI 25-26 NOVEMBER 2017, ADNEC EXHIBITION CENTRE, ABU DHABI

The National Department of Tourism, through the International Market Access Support Programme, invites eligible tourism enterprises to apply for support to participate at the International Travel Week (ITW) Abu Dhabi taking place on 25 – 26 November 2017.

The ITW Abu Dhabi is the world's only dedicated Muslim majority travel event. The exhibition combines five (5) tourism exhibitions and conferences each addressing the needs of the fastest growing and most important sectors for the Muslim majority travelers.

A limited number of spaces on ITW Abu Dhabi have been secured for enterprises that will be supported under the International Market Access Support Programme. The spaces are specifically aimed at assisting small to medium enterprises that wish to showcase packaged tourism products and experiences to the Muslim traveller market. The guidelines for the International Market Access Support Programme are available on the **Department's website** (www.tourism.gov.za). The Guidelines outline the eligibility criteria, application process, and support offered.

For ITW Abu Dhabi, the Department will offer partial financial assistance in capped amounts towards the cost of airfare and accommodation on a reimbursement basis to qualifying enterprises, as well as participation fees that will be paid by the Department on behalf of qualifying applicants.

In line with programme guidelines, reimbursement of costs incurred will be based on the following capped amounts:

- Accommodation R 3 528.00 per person per night, linked to the duration of the roadshow;
- Flight R12 100.00, based on an economy class return flights; and
- Participation fees for approved tourism enterprises will be paid for by the Department.
